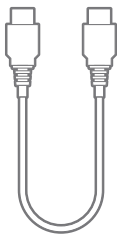

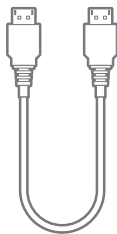

Monitor (front view)



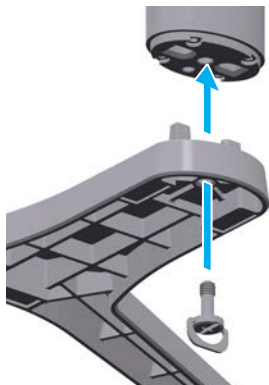
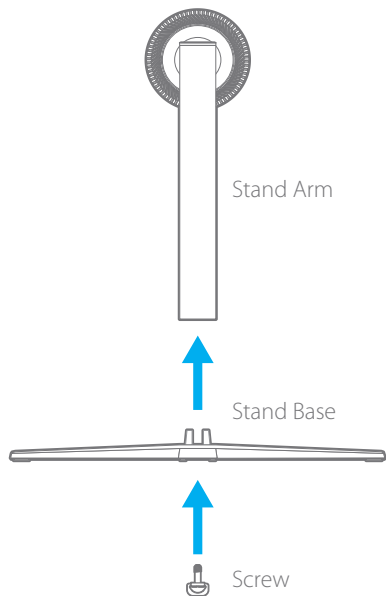

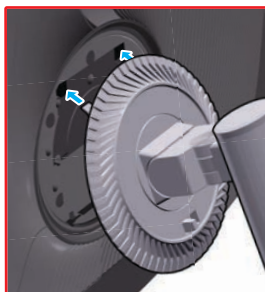


# Assembling the Monitor

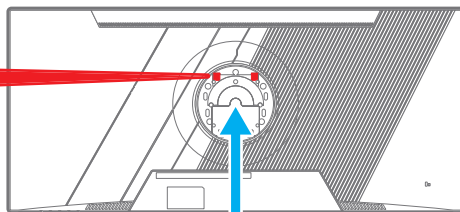
1. Remove the screw from the stand arm.
2. Connect the stand base to the stand arm, then insert and tighten the screw as shown below.



3. Insert and snap in the assembled stand to the monitor and make sure it is securely connected and locked into the monitor.



Insert and snap in the assembled stand to the monitor



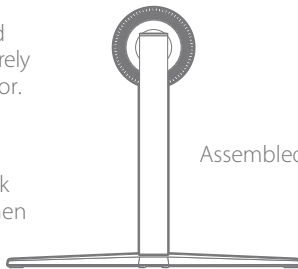

You hear a click sound when the stand is securely locked into the monitor.



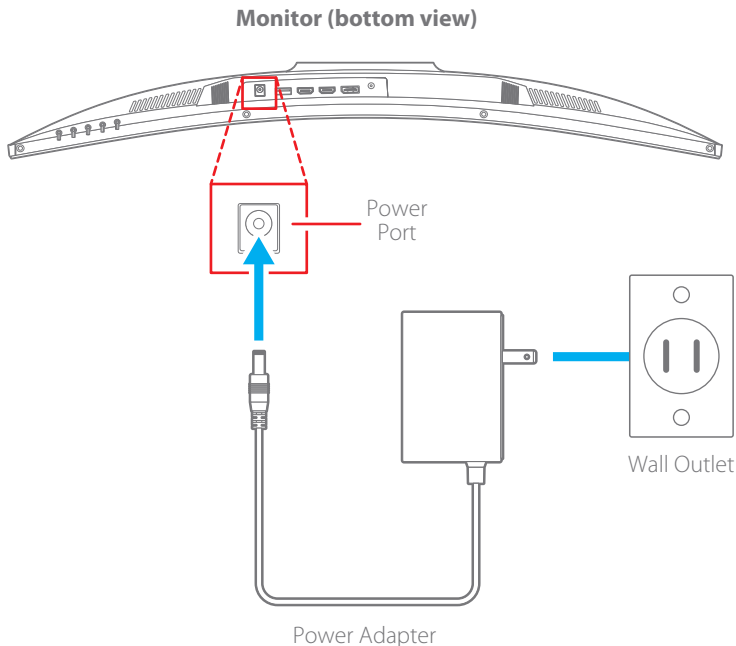
Slide and hold the lock switch to the right when you remove the stand from the monitor.



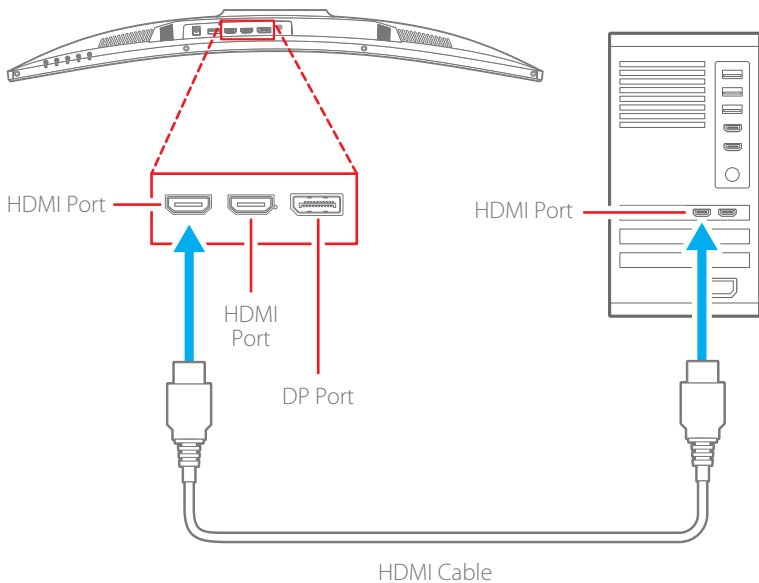
Assembled Stand
